2. Consideration of the Purchase of the Burton/Robinson Property as an addition to Sierra Azul Open Space Preserve (Santa Clara County Assessor Parcel Number 562-20-023).

Real Property Manager Mike Williams provided the staff presentation describing the property, geographical features of the area, the site's history and its resources values including watershed and viewshed protection. Mr. Williams described the purchase's relation to Measure AA regarding public access to the Loma Prieta area of Sierra Azul and developing regional trails. Mr. Williams described the property's landscape, which includes rolling uplands, oak woodland, mixed chaparral, and knob cone pine. Mr. Williams also described the property's habitat, which includes Purple Martins, Yellow Warblers, California Quail, Mountain Lions, Deer, Coyotes, Bobcats, Grey Fox, and Bats. Mr. Williams provided information on structures on the property, which in turn provide a lot of clean up and site restoration opportunities. Finally, Mr. Williams outlined the purchase terms of the property including its proposed purchase price of \$400,000, which \$50,000 withhold in Escrow from purchase price for cleanup of the property until September 30, 2015. Mr. Williams also discussed a license agreement with buyer for removal of personal property, horses, and site cleanup.
