CALL TO ORDER

Director Hanko called the meeting of the Real Property Committee to order at 2:03 p.m.

ADOPTION OF THE AGENDA

Motion: Director Harris moved, and Director Hanko seconded a motion to adopt the agenda.

COMMITTEE BUSINESS

1. Approval of Real Property Committee Minutes for April 11, 2017.

Motion: Director Harris moved, and Director Hanko seconded a motion to approve the April 11, 2017 Real Property Committee meeting minutes, as amended.

2. Consideration of a purchase of the Lobitos Creek conservation and public trail easement as an addition to Purisima Creek Redwoods Open Space Preserve in unincorporated San Mateo County a portion of Assessor's Parcel Numbers 066-320-160.

Real Property Manager Mike Williams provided the staff presentation describing the property, geographical features of the area, habitat and resource values of the property, and nearby properties previously purchased by the District. The proposed purchase is included in Measure AA portfolio 3. Finally, Mr. Williams outlined the purchase terms and conditions of the conservation easement, including annual monitoring.

Director Harris requested information regarding a future burrowing owl study be included in a future action plan.

Director Harris inquired regarding the potential for a future trail across the property.

Mr. Williams explained a trail easement is included in the conservation easement, and staff would consult with the property owners before building the trail.
