Governmental Affairs Specialist Joshua Hugg reviewed the District's draft 2019 Legislative Program and outlined the proposed 2019 legislative priorities, proposed policy positions, and program updates.

Director Riffle recommended the District's position on anticoagulant rodenticides should be clarified to only support efforts which eliminate the use of second-generation anti-coagulant rodenticides.

Acting Assistant General Manager Kirk Lenington agreed and stated there are no circumstances in which the District uses this category of rodenticides.

Director Riffle recommended a language change on legislative priority related to Proposition 68 implementation to clarify that the prioritization of funding allocations or eligibilities for park bond funds and resulting grant programs should be designed in a manner that benefits the District.
