Comments to be read into the record *

For the District to manage natural resources and native vegetation according to CEQA--Must NEVER utilize the following methods, because they destroy the very resources you are supposed to preserve:

- 1.) Plowing fire breaks, because they drive native seeds in soil too deep, so they can never sprout, producing permanent weed-covered areas. Alternative is mowing when weed seeds are still green, and weeds will be replaced by dormant native seeds in the soil. See-- 70 acres at 300 Byers Lane, La Selva Beach and 15 acres across from 144 Alta Mesa in Woodside—Mowing only, no seeds sown, solid native cover produced, and the most fire-safe possible.
- 2.) Fire or prescribed burns, because weed can take advantage faster than the natives can, like the five Calfires at Russian Ridge. Also, fires pyrolize surface organic matter and nutrients, lowering levels below native seedling survival—see USFS and BLM fire—soil studies.
- 3.) Exotic animal grazing—many reasons, A.) Animals eat tender natives first, before the weeds, B.) Produce methane 30X worse than CO2, C.) Cow "mine" organic matter and nutrients from the soil, dropping levels below what is needed for native seedling survival. D.) Grazing will never convert the weeds back to natives, because those animals love the natives too much.

The CEQA-safe and best alternative to either plowing, fire or grazing, and the least damaging to the resources—is mowing the weeds while seeds are still green, and unearth dormant native seeds, to produce the most fire-safe environment that can exist on the District's preserves?

Dear Board Members,

I hope that this message finds you well. I am writing to ask a question about the closure of various parks and open spaces in the region as a response to the COVID-19 epidemic.

I understand that social distancing is essential in order to minimize the number of people who contract the disease simultaneously. I understand that the closure of parks and open spaces is part of the response to this. At the same time, I recognize that it is valuable for people to be able to go outside during this time.

I have made some observations about the impact of closing outdoor spaces:

- 1. Because many parks and bike paths are closed, there are constantly people walking and biking in the streets in order to get outside and exercise. The ability to be outside has a large positive impact on people's physical and mental health and well-being.
- 2. With more people on the streets, the risk of accidents increases and drivers must be more careful.
- 3. Having more options of places to go allows people to spread out more; having fewer options concentrates them.
- 4. People who live far from beaches are still driving to them, parking on the roads, and earning tickets. This is a bad day for everyone involved.

I understand that some people choose not to obey social distancing recommendations, and that open space closures and strict policies are one response to this. But I do not believe that the majority of people disobey social distancing recommendations, nor do I believe that social distancing and closing outdoor spaces must be synonymous. I think we can do better, especially since this situation may continue for a while yet.

Are there other rules or improvements on existing rules that will help keep people distanced yet allow them to use open spaces? The options that come to mind include:

1. Setting a capacity for each open space to limit the number of people who can go in at once. This way, everyone has a chance of getting to visit, they just need to get there early, go at less busy times, or wait their turn.

2. Allocating different days and times for people to visit an open space by some method (for example, differentiating by address, car registration, or last name, or by lottery). People would know that they can go on a certain day, so they might not feel the need to all go on the same day or to break the rules by going on a different day.

Yes, implementing such a system would take time and effort, and it wouldn't be perfect. But I am sure that people with more knowledge and experience will have even better ideas than the ones above. If current policies could be improved to allow people to be in open spaces, isn't it worth trying?
