SUMMARY

The Fiscal Year 2023-24 (FY24) year-end progress report looks back at the Midpeninsula Regional Open Space District's (District) advancements in achieving its goals as set out in the FY24 Budget and Action Plan. Included as supplemental attachments to this report are the FY24 Major Accomplishments Report (Attachment 1) and the FY24 Year-End Action Plan Progress Report (Attachment 2). The Major Accomplishments Report is a public-facing document that presents significant project milestones, program achievements, grants secured and special acknowledgements in FY24. The Year-End Action Plan Progress Report lists each project on the FY24 Budget and Action Plan, including the fiscal year project scope, project scope status and, where applicable, specific reasons for project scope changes or deviations from the anticipated project timeline. A broad analysis of this year's action plan progress is included in this report.

DISCUSSION

FY24 Major Accomplishments Report

The District proudly presents the FY24 Major Accomplishments Report (Attachment 1). This public-facing document showcases significant project milestones in addition to programmatic or operational achievements, secured grants and special acknowledgements that have furthered the District's mission and Coastside mission:

Midpen mission: To acquire and preserve a regional greenbelt of open space land in perpetuity, protect and restore the natural environment, and provide opportunities for ecologically sensitive public enjoyment and education.

Coastside mission: To acquire and preserve in perpetuity open space land and agricultural land of regional significance, protect and restore the natural environment, preserve rural character, encourage viable agricultural use of land resources, and provide opportunities for ecologically sensitive public enjoyment and education.

The Major Accomplishments Report has become a flagship publication in recent years, presenting the District's outstanding achievements in a visually engaging and narrative-driven

format. The District's work has a lasting impact on the region, and the infographics and photos in the report effectively illustrate this significance. The report highlights achievements through the lens of the District's four core program areas:

- Land Acquisition and Preservation
- Natural Resource Protection and Restoration
- Public Access, Education and Outreach
- Assets and Organizational Support

The FY24 report also highlights the District's decisive action on achieving 12 major Measure AA milestones and the agency's commitment to prioritizing the following key focus areas:

- Agriculture
- Diversity, Equity and Inclusion
- Wildland Fire Resiliency

Key accomplishment highlights include:

- Preserved 845 acres of additional open space land
- Fuel reduction treatments completed at 8 different preserves
- Pond improvements that support the endangered San Francisco garter snake and threatened California red-legged frog
- Installed 14,000 linear feet of wildlife-friendly fencing in support of the conservation grazing program
- Full cleanup of a historic landfill at Bear Creek Redwoods Preserve
- Adoption of a new Agricultural Policy
- Multiple storm damage repairs to trails and roads impacted by the 2022-23 winter storms
- Opened 1.1 miles of additional trail across 3 preserves, including completing repairs to reopen Alpine (Road) Trail at Coal Creek Preserve
- Substantially completed more than 2 miles of trails within northeastern Bear Creek Redwoods Preserve that will open to the public in October 2024
- Arrived at final public access recommendations by a citizen working group for the Hawthorns Area of Windy Hill Preserve
- 4,547 volunteer docent hours, 249 guided public activities and over 2,000 participants
- 22 field trips serving 349 students
- 145 volunteer activities that logged 10,627 hours of land stewardship work
- 1,937 volunteer trail reports in support of land management
- Received \$9.5 million in grants with another \$8 million under review
- Awarded \$250,000 in grants to 5 local community organizations focused on connecting people to nature, climate resilience and indigenous land stewardship
- Launched the Trail Explorer app to enhance the preserve experience for visitors
- Received 8 awards for excellence in innovation, technical solutions, parking design and financial reporting

FY24 Capital Improvement and Action Plan Progress

The FY24 Major Accomplishments Report summarizes the progress made to carry out the annual Capital Improvement and Action Plan (CIAP). The CIAP identifies the project scopes, schedules, and budgets of priority capital projects. Many projects span multiple fiscal years and involve collaborative partnerships. On June 14, 2023, the District's Board of Directors (Board)

adopted the FY24 Capital Improvement and Action Plan (CIAP) with a total of 125 projects. Subsequently, the District added eight projects mid-year, resulting in a total of 133 projects. On average, the District completes approximately half of all project scopes identified for the fiscal year and makes significant progress on the other half (see Table 1). Taken together, the District completed or made progress on 118 (88%) project scopes in FY24.

Table 2 provides a preliminary look at the FY24 CIAP budget remaining by fund and project scope status. Unaudited actuals show a net budget remaining of \$3.2 million. Where applicable, budget overages are shown in parentheses. As shown in Table 2, project scopes deemed "in progress" as of June 30, 2024 account for most of the budget remaining.

Table 3 summarizes the primary factors affecting FY24 CIAP budget statuses by fund. Positive impacts relate to reassigning outside contracted work to internal Midpen crews (e.g., cost savings), securing additional grant dollars to offset District funds, and the distribution of grant funds sooner than expected. Negative impacts largely relate to delays in securing other grants,

staffing issues, regulatory hurdles with permitting delays, extended partner coordination, and supply chain disruptions for vehicles, equipment and materials.

10 - General Fund Operating	The Los Gatos Creek Watershed – Wildland Fire Resiliency project (61023) also had a significant budget remaining. This was due to Santa Clara County Firesafe Council, the lead partner on the grant, performing the acres of fuel treatment with additional grant funds. Therefore, more grant funds were allocated to complete the fuel treatment work on our behalf, resulting in a greater offset of District funds.		
	Other FY24 project scopes (ADA Barrier Removal and Wildland Fire Capacity-operating) were not completed as planned due to the redirection of staffing resources to secure federal grant funding for 2022-23 winter storm damage projects.		
20 - Hawthorns	The budget remaining in Fund 20 is primarily due to the Hawthorns Historic Complex Partnership project (VP06-003). In FY24, staff pivoted to focus on a potential partnership project for one specific historic building affecting the scope and schedule for evaluating the future use and management of the larger site and remaining buildings.		
30 - Measure AA Capital	The Bear Creek Redwoods (BCR) Phase 2 Trails (MAA21-011) and Highway 17 Crossing projects (MAA20-001 and MAA20-002) experienced external partner agency issues, namely additional coordination with and an extended permitting review by Caltrans for the BCR Phase 2 Trails to address multiple technical requirements, and multiple meetings with and response to comments from responsible agencies on the draft CEQA/NEPA document for the Highway 17 Crossing projects. Also, the Alpine Road Regional Trail project (MAA10-001) was impacted by key staff turnover that affected the permit closeout schedule. Moreover, the County was also delayed in closing out the permit on their end.		
	The budget adjustment for the Johnston Ranch property purchase (MAA01-005) was \$700,000 short because the close of escrow occurred sooner than expected due to the timing of final grant reimbursement approvals. As a result, the adjustment process also did not account for \$700,000 in state grants.		

The budget remaining in Fund 40 is due to ongoing supply chain issues with vehicle and machinery purchases.
Also, the Sierra Azul Ranger Residence project (35004) was subject to several unexpected permitting requirements set forth by Santa Clara County Department of Environmental Health that delayed construction.
Other FY24 project scopes (Bear Creek Redwoods Parking Lot Culvert, Miramontes Ridge Madonna Creek Dam Repair, Wildland Fire Capacity-capital, and Skyline Ridge Road and Big Dipper Inholding) were not completed as planned due to the redirection of staffing resources to secure federal grant funding for 2022-23 winter storm damage projects.

For additional detail, Attachment 2 has specific information on each FY24 CIAP project, including the FY24 project scope, project scope status and, where applicable, the reason(s) for project scope changes or deviations from the anticipated project timeline.

Looking Forward

As noted in the 2023 Financial and Operational Sustainability Model (FOSM) Refresh, addressing permitting issues can enhance operational efficiency. Staff have already begun making improvements in this area. In FY24, the District worked with the County of San Mateo to streamline local permits by obtaining a 5-Year Master Permit for routine maintenance and project work. The master permit is expected to reduce project delays due to County permitting over the next five years. Staff will continue to explore streamlined permitting options, including blanket approvals, self-permitting and consolidating permit processes.

The 2023 FOSM Refresh also proposes the hiring of over 90 employees over 10 years with a short-term "catch up" period from FY24 to FY27 of 32 FTEs. The additional capacity will bring added support to project delivery, reducing the potential for delays due to staffing issues and enhancing overall productivity.

FY24 Major Accomplishments Report

JULY 1, 2023-JUNE 30, 2024

As we conclude fiscal year 2024, this report highlights significant accomplishments in Midpeninsula Regional Open Space District's (Midpen's) priority program areas.

PRIORITY PROGRAM AREAS

Land Acquisition and Preservation

Midpen seeks to purchase or otherwise acquire interest in the maximum feasible area of strategic open space land within the District, including baylands, foothills and ridgelines, and link its open space lands with federal, state, county and city parklands and watershed lands.

Natural Resource Protection and Restoration

Midpen protects and restores the natural diversity and integrity of its resources for their value to the environment and the public.

Public Access, Education and Outreach

Midpen provides public access to the open space lands for low-intensity recreational uses to everyone, regardless of physical abilities or economic status.

Assets and Organizational Support

Midpen employs a highly capable and professional staff and provides them with the facilities and resources needed to run an efficient and responsible organization on behalf of the public.






MAA PROPERTY ADDITION TO LA HONDA CREEK OPEN SPACE PRESERVE

With the completed acquisitions of the Eberhard property in December of 2023 and the Fifths property in May of 2024, a total of 156 acres were added to La Honda Creek in FY24. These acquisitions protect redwood forested lands and wildlife habitat on the headwaters of La Honda Creek within the San Gregorio watershed. In terms of public access, the Eberhard acquisition advances a connection between La Honda Creek and El Corte de Madera Creek Open Space Preserves. The Eberhard acquisition was made possible in part by Measure AA funding and a grant from the Moore Foundation (\$1 million).

TR AIL EASEMENT ADDITION TO PURISIMA CREEK REDWOODS **OPEN SPACE PRESERVE**

Midpen closed escrow on a forested, 3.7-acre trail easement area as an addition to Purisima Creek Redwoods. The Boothroyd-Krebs public trail easement is located southerly adjacent to the preserve and may be utilized in the future as part of the Purisima-to-the-Sea Trail or other trails within the preserve.

TR AIL EASEMENT ADDITION TO TEAGUE HILL OPEN SPACE PRESERVE

Midpen secured a 50-foot-wide public trail easement as an addition to Teague Hill Open Space Preserve, protecting public access on an existing segment of the Skyline Trail.





PROPERTY ADDITION TO MIRAMONTES RIDGE OPEN SPACE PRESERVE

In May of 2024, Midpen finalized the purchase of a 644-acre portion of the undeveloped uplands area of the Johnston Ranch property from the Peninsula Open Space Trust (POST). The purchase continues to protect 1.2 miles of Arroyo Leon Creek, a tributary to Pilarcitos Creek, with potential spawning and rearing habitat for steelhead trout. The purchase also provides opportunities for public access through expanding and connecting local trail systems. This acquisition was made possible in part by Measure AA funding and grants from the California Coastal Conservancy (\$500,000) and California Department of Parks and Recreation Habitat Conservation Fund (\$200,000).

PROPERTY ADDITION TO SIERRA AZUL OPEN SPACE PRESERVE

In September of 2023, Midpen closed escrow on a 40.83-acre property as an addition to Sierra Azul. The Vielbaum property rests at 3,400 feet in elevation and is bordered by the 19,437.84-acre Sierra Azul Preserve to the north, east and south and private property to the west. The purchase protects fire-adaptive California bay forest and serpentine leather-oak chaparral within the Upper Los Gatos Creek and Upper Guadalupe Creek watersheds. In March of 2024, Midpen obtained an access easement over several road segments in the Rancho de Guadalupe area of Sierra Azul for patrol and maintenance purposes.



Natural Resource Protection and Restoration



WILDLAND FIRE FUEL REDUCTION AND WILDLAND FIRE RESILIENCY TREATMENTS THROUGHOUT THE DISTRICT

Midpen remains hard at work to support healthy forests that are resilient to wildland fire and climate change as part of our Wildland Fire Resiliency Program. Staff continue to identify partnerships, grant funding and ways to increase Midpen's resource management capacity.

Midpen is currently involved in several collaborative groups to create a more fire resilient region. As part of Midpen's work with the Los Gatos Creek Watershed Collaborative, 254 acres at Bear Creek Redwoods, Long Ridge and Sierra Azul Open Space Preserves have received forest health treatments. In addition, fuel reduction work was completed in areas of La Honda Creek, Windy Hill, Coal Creek, Skyline Ridge and Russian Ridge Open Space Preserves by FireSafe San Mateo, Woodside Fire Protection District, San Mateo RCD and Midpen staff.

One of many ways Midpen prepares for fire season is an annual spring training for our rangers and other wildland firefighting-certified staff to keep their skills current. This year, Midpen also identified five staff members as future Resource Advisors and have sent them to obtain their red card training, the first step in a two- to three-year training program. The primary role of a Resource Advisor is to identify and evaluate potential impacts and benefits of fire operations (wildland or prescribed fire) on natural and cultural resources.

Meanwhile, in an effort to train the next generation of land and fire management stewards, Midpen teamed up with the San Francisco Conservation Corps, who have already begun forest health work in Midpen preserves. Midpen trained the Corps members in topics such as wildlife biology and fire ecology, as well as land management techniques like preventing the spread of invasive species, arboriculture and sensitively thinning trees and vegetation for conservation purposes.

WATER QUALITY IMPROVEMENTS IN THE SAN GREGORIO CREEK WATERSHED

Midpen owns roughly 40% of the 33,000-acre San Gregorio Creek watershed. San Gregorio Creek was first listed as a sediment-impaired waterbody in 1998 under the Federal Clean Water Act. This year, in coordination with the San Francisco Bay Regional Water Quality Control Board, Midpen completed a sediment inventory

of the watershed which identified the top 20 sites for reducing sediment. Of the 446 stream-crossing and culvert sites assessed, 13% showed evidence of active erosion, 31% had potential erosion while the majority (56%) had a low potential for erosion. Overall, Midpen's relative sediment contribution is low compared to the total human-caused sediment delivery within the watershed. Thankfully, Midpen's routine maintenance and best management practices have provided a substantial head start in reducing sediment delivered to San Gregorio Creek. A final report is now available and will further enable the protection and enhancement of water quality and stream habitat over a long-term period for listed species such as steelhead trout and coho salmon.



HABITAT IMPROVEMENTS FOR TURTLES AND BATS AT LA HONDA CREEK **OPEN SPACE PRESERVE**

The western pond turtle (Actinemys marmorata) is California's only native freshwater turtle. Unfortunately, this California "species of special concern", has experienced population reductions of 75-80% due to loss

of habitat, predation and competition from non-native turtle species. This year, Midpen successfully completed spillway repairs at Lower Turtle Pond, located within La Honda Creek. Ponds provide prime habitat for turtles; their time in the sun is essential to shell development and overall health. These improvements not only support special status species recovery for the western pond turtle, but also the federally endangered San Francisco garter snake (Thamnophis sirtalis tetrataenia) and federally threatened California red-legged frog (Rana draytonii). The project also improves flood resiliency and maintains conservation grazing water availability.



La Honda Creek is also home to eight different species of bats, several of which are California state species of special concern and are extremely beneficial to the

environment. Several bats were found in the immediate area of the 160-year-old White Barn. The barn, located along the Cielo Trail, was in dire need of structural repairs for preservation and public safety. This year, Midpen completed stabilization and repairs, which included bat-specific enhancements to the interior of the barn.



WILDLIFE-FRIENDLY LIVESTOCK FENCES FOR GRAZING UNITS AT PURISIMA CREEK REDWOODS AND LA HONDA CREEK OPEN SPACE PRESERVES

Conservation grazing is integral to the management of approximately 15,000 acres of the District's Open Space Preserves on the San Mateo County coast. Coastal prairies and native grassland comprise one of the most biodiverse and threatened ecosystems in North America. In September of 2023, Midpen completed approximately 14,000 linear feet of wildlife-friendly livestock fences in the 450-acre Lobitos/Elkus property and the neighboring 340-acre Lobitos Ridge property, which protect riparian resources in both the Lobitos Creek and San Gregorio Creek watersheds.



🗽MAA LANDFILL REMEDIATION AT BEAR CREEK REDWOODS OPEN SPACE PRESERVE

When Midpen acquired Bear Creek Redwoods in 1999, the land had been heavily used and manipulated by human hands. As part of Midpen's mission to reclaim natural areas and restore the land's natural functions to support a healthy thriving ecosystem, staff recently completed the cleanup of this old landfill discovered within the preserve. The cleanup involved two distinct efforts: systematically collecting and documenting as many historic artifacts as possible, and removing contaminated soil and other hazardous waste, which included 274







tons of hazardous soils and ash, three tons of recyclable metals, one cubic yard of non-friable asbestos containing materials, 32 tires, 1.5 tons of general waste and debris and an undocumented 500-gallon fuel storage tank along the Alma Loop Trail.

MONITORING OF LEHIGH QUARRY RIDGELINE EASEMENT AND

RECLAMATION PLAN

Midpen hired a consultant to prepare a report on ridgeline easement conditions and track conditions for three years. The original easement was put in place to avoid further loss of the ridgeline and ridgeline views from quarry activities. After a second year of monitoring, major breaches of the ridgeline easement before 2022 were clear. Since then, no one has reported major system failures. But, heavy rains worsened cracks and caused landslides in the quarry wall. Also, a monument delineating the boundary of a separate conservation easement went missing. Midpen requested Lehigh to replace the monument, per the easement. Midpen also supported Santa Clara County's new mining ordinance. It requires Lehigh to maintain a 50-foot buffer from groundwater. It also supported the completeness of Lehigh Quarry's 2023 Reclamation Plan Amendment application.



ADOPTED NEW AGRICULTURAL POLICY

After extensive public and stakeholder outreach, Midpen adopted a comprehensive agricultural policy in November 2023. The policy reaffirms Midpen's work preserving upland grazing areas protected through acquisition and conservation grazing leases, which support both agriculture and grassland habitats. It also adds policy framework working with partners to support the preservation of row crops and other intensive agricultural lands through affirmative agricultural easements and to support farm worker housing. The policy emphasizes ecologically sensitive agricultural practices, operations that embrace Diversity, Equity and Inclusion (DEI) and consideration for local preference when selecting agricultural tenants.



Public Access, Interpretation, Education & Outreach

2022-23 WINTER STORMS REPAIR UPDATE

The winter storms of 2022-23 demonstrated how destructive winter storms can be to trails. The unprecedented deluge caused landslides, toppled thousands of trees and disrupted access to preserves and trails for visitors and Midpen staff. This year, Midpen crew repaired the damage to trails and culverts as well as two major landslides in Bear Creek Redwoods and Sierra Azul Open Space Preserves. Whether we are in for a quiet winter or a series of intense storms this year, we have Midpen's field crews to thank for their tireless work.

GUIDED HIKES AT CLOVERDALE RANCH OPEN SPACE PRESERVE

Following the acquisition of Midpen's 27th open space preserve in FY23, Midpen has welcomed the public to Cloverdale Ranch. In July of 2023, District staff hosted two initial "Community Field Day" events, with three subsequent docent-led hikes throughout the fiscal year, inviting people to experience and learn more about coastal grasslands and the role of conservation grazing at the preserve.



TRAIL PROJECTS AT BEAR CREEK REDWOODS, COAL CREEK, PULGAS RIDGE, RUSSIAN RIDGE AND LA HONDA CREEK OPEN SPACE PRESERVES

This year, Midpen opened approximately 1.1 miles of additional trails to the public! In coordination with the City of San Carlos, Midpen designated a new trailhead with amenities and an unnamed 0.1-mile trail segment at Pulgas Ridge. The new trail segment is open to hiking and dogs on leash and connects the trailhead with the Dusky-footed Woodrat Trail. At Russian Ridge, Midpen utilized a former interior unpaved road to access a beautiful ridgeline vista point, opening the 0.5-mile Fog Drift Vista Trail for hiking, equestrian and bicycle use.



Meanwhile, Midpen completed trail improvements in Coal Creek that reestablished the Alpine Trail as a safe connection between Portola Valley and Skyline Boulevard. In fall of 2023, work concluded on two retaining walls that will prevent a total washout at the trailhead to maintain this portion of the trail for visitor use and emergency response vehicle access, while reducing sediment into Corte de Madera Creek. In spring of 2024, Midpen completed the removal of the informal bypass trail and opened connections to the new, more sustainable 0.5-mile bypass trail.

In Los Gatos, Midpen staff and contractors are finalizing more than two miles of trails within the northeastern portion of Bear Creek Redwoods that will be opened to the public in the coming fiscal year. These trails will increase the land's ecological health and eventually provide opportunities to explore an area of the preserve that was previously only accessible via permit. This project is made possible in part to Measure AA funding and a \$2.5 million grant from the California Natural Resources Agency.

On the coast, Midpen secured permits and initiated trail construction that will ultimately connect visitors from the

Harrington Creek Trail in the southern area of La Honda Creek to the central and northern areas of the preserve. Since first opening to the public in 2017, the preserve has become a regional destination for birding.



HIGHWAY 17 TRAIL OVERCROSSING SELECTED, DESIGN PLANS AND ENVIRONMENTAL REVIEW UNDERWAY

While greenbelts and open spaces are critical for the health of animals and people alike, their benefits are exponentially greater when they are connected. Midpen reached a major milestone in the Highway 17 Wildlife and Trail Crossing project. In May of 2024, the Midpen board of directors selected the northern trail overcrossing location, which will connect the Los Gatos Creek Trail to El Sereno Open Space Preserve. The



future trail overcrossing will connect over 50 miles of existing regional trails and will also be accompanied by a separate wildlife undercrossing. This past fiscal year, Midpen and our partners moved our conceptual design plans toward the preparation of more detailed construction plans and administered the public review period for the environmental analysis document for the project.

PLANNING AT PURISIMA CREEK OPEN SPACE PRESERVI



MAA. Along Skyline Boulevard in the Santa Cruz Mountains, the vision of a public trail encircling Bay Area ridgetops is being realized piece by piece. The San Francisco Public Utilities Commission (SFPUC) is planning a new Bay Area Ridge Trail segment on their watershed lands that would terminate near Purisima Creek Redwoods' North Ridge parking area. This year, the Midpen board of directors approved the preferred conceptual parking design for expanded parking to accommodate the new Bay Area Ridge Trail segment, as well as the Highway 35 trail crossing location that will connect the east and west trail systems in this northern area of the preserve. This project is made possible in part due to partnership funding from SFPUC, POST and the Bay Area Ridge Trail Council.



Connecting to the coast, planning continues for the Purisima-to-the-Sea Trail (which will become a significant portion of the future and larger Bay to Sea Trail) and a new coastal trailhead and parking area. Midpen's board of directors have approved contracts for design development and environmental review for these projects, which are now underway.

Preserve-wide, Midpen is performing multimodal access planning to understand how transportation demand management strategies, such as shuttle services, carpool and reservation parking and real-time parking information, can be incorporated into existing and future trailheads to improve the experience for both preserve visitors and neighbors. As part of this work, the board approved the development of a formal carpool lot at the main Rancho San Antonio Open Space Preserve trailhead based on findings from a prior carpool pilot program. Design work to repurpose the lower west lot for carpools will begin in FY25. This project was awarded the California Chapter Northern Excellence Award!

PLANNING AT HAWTHORNS AREA OF WINDY HILL OPEN SPACE PRESERVE

Midpen formed a public access working group in June of 2023 to collaborate with Midpen on a plan for introducing public access to the 79-acre Hawthorns Area of Windy Hill. After a total of seven meetings, the working group developed their final recommendations for parking and trails, which will be presented to the Planning & Natural Resources Committee later in 2024.



As part of a separate planning effort, Midpen formed and worked with an Ad Hoc Committee to draft the long-term vision and goals for the 13-acre Hawthorns Historic Complex, located within Hawthorns Area. At the direction of the Ad Hoc Committee, Midpen staff engaged a structural engineer to further evaluate potential

reuse options and cost estimates for the Hawthorns mansion. Midpen staff also developed an interim stabilization and debris removal plan that proposes to mitigate structural degradation over the next five to 10 years for structures that retain historical integrity for board consideration to lay out a pathway for on-the-ground stabilization and cleanup work The Historic Hawthorns Complex vision and goals will be brought to the board of directors for approval in FY25.

INTERPRETATION AND EDUCATION PROGRAMS

Docents are long-term volunteers who educate and inspire preserve visitors through hosting interpretive hikes and bicycle/horseback rides, welcoming visitors on weekends at the Daniels C. Nature Center, located in Skyline Ridge Open Space Preserve, or conducting field trips for elementary school students.



TRAILS AND STEWARDSHIP PROGRAMS

Trails and Stewardship Program volunteers deliver hands-on landscape restoration, assist visitors along the trails, contribute to community science and increase community awareness through both short and long-term programs.

LEVERAGING GIS TO VISUALIZE MIDPEN LAND AND COMMUNITY

While spreadsheets are valuable for data organization, mapping unlocks a deeper understanding. It reveals spatial distribution, concentration areas and empowers data-driven decisions with a geographic lens. This year, Midpen's Geographic Information Systems (GIS) team released several applications for users to explore:

It took more than three years for interns in the Planning department to walk and assess all 255 miles of Midpen's trails to develop **Trail Explorer**, an interactive online experience designed to help visitors plan an outing to Midpen preserves. Trail Explorer was launched on November 15, International GIS Day, and subsequently received the **Merit Award in Technology** from California Trails and Greenways.



Open Data Midpen, Midpen's central hub of GIS data and interactive mapping applications, is now available for visitors and tech-savvy map enthusiasts who want to plan their outdoor activities or learn more about Midpen preserves.

For those looking to explore demographics in California and reveal meaningful trends on a census tract level, Midpen proudly presents the **Disadvantaged Communities Explorer** and the **California Demographics Data Explorer** dashboards. The dynamic dashboard duo received an *Innovation* **Award** from the California Society of Municipal Finance Officers. The data is updated annually to ensure relevance and accuracy.

CUTTING THROUGH GREEN TAPE

With over 900 culverts, 150 trail bridges and 230 miles of streams across our preserves, Midpen's professional trails crews are constantly making improvements and conducting ongoing maintenance activities. Administering these activities as a program, as opposed to individual activities, allows us to apply a consistent set of methods, best management practices and impact avoidance approaches. This year, Midpen worked with San Mateo County to streamline the local permitting process, which will reduce project delays over the next five years.

FINANCIAL & OPERATIONAL EXCELLENCE

Completed a comprehensive update of Midpen's Financial Organization Sustainability Model with an emphasis on a five-year detailed outlook on program delivery, organization, reporting structure, staffing and financial sustainability.



Other projects will foster connections and learning between groups, enhancing capacity for climate initiatives and resilience efforts and promote a better understanding of Indigenous land stewardship practices.
